

# CORPORATE RESPONSIBILITY POLICY STATEMENT

#### **Our Commitment**

John Perkins Construction is committed to reducing our Greenhouse Gas (GHG) emissions to achieve Net Zero by 2050. At the heart of our CSR Policy is our carbon footprint which we measure and report quarterly according to the Greenhouse Gas Protocol carbon accounting standard. Our footprint covers our direct scope 1 and 2 emissions generated from buildings, transport, travel, waste and the use of plant fuel on site.

It is John Pekins's Carbon Policy to reduce the direct impact of our operations on climate change by focussing on the areas where we can have the greatest impact:

- Carbon emissions resulting from employee business travel
- Carbon emissions resulting from commercial vehicles
- Carbon emissions resulting from plant fuel
- Carbon emissions resulting from our offices

Our internal carbon action plan follows best practice in carbon management in order to facilitate achievement of our targets. We follow the abatement hierarchy below for the management of our direct carbon emissions:

#### Avoid

- We are installing and improving existing communication technology across our estate to reduce business travel and challenging whether each journey is really necessary.
- We are introducing GPS systems to a selection of suitable commercial vehicles to challenge efficient usage.

### Reduce

- We are constantly seeking ways to improve our carbon emissions performance whether through measurement of energy consumption in our offices or the management of average C02 emissions in our fleet.
- Each business group has developed detailed action plans to reduce their company vehicle emissions in line with the group target. Increased choices of lower CO2 vehicles are available to company car drivers and we are committed to promoting and measuring fuel efficiency across our businesses.

## **Influencing Others**

- Our travel management company fully supports our sustainability policies and is actively working and challenging our people who make bookings to reduce the need to travel.
- We will work in partnership with our clients and supply chain partners to assist them in achieving sustainable working environments and supporting their sustainability innovations.
